## **UPDATE: Electronic Forms**

The **ServiceOntario Account** for businesses is becoming the **Ontario Business Account** on **February 23, 2026**. If you use **electronic forms**, there may be changes to how you access them:

Access to all electronic forms on the ServiceOntario Account will be unavailable from **6:00PM on February 20, 2026, to 11:59PM on February 22, 2026**, as a result of the transition.

### **Electronic Forms Moving to the Ontario Business Account**

Electronic forms from the Ministry of Finance (MOF) and the Ministry of Labour, Immigration, Training and Skills Development (MLITSD) will be moving from the ServiceOntario Account and will be available on the Ontario Business Account effective February 23, 2026.

Please note that any MOF or MLITSD electronic forms that are moving to the Ontario Business Account **will not be transferred** if they remain in **draft status** after **6:00PM on February 20, 2026**. Please ensure all draft forms are submitted before this deadline.
